This agreement is between the "Horse Owner" _____, and Peggy Klump, owner of Peak Performance Dressage hereafter referred to as the "Trainer".

This agreement is entered into on (today's date) _____. The actual start date of the horse's training in accordance with the terms of this agreement will be the date the horse arrives at the stable OR the date the owner listed in the box above.

Whereas, Owner owns/leases the horse described and desires Trainer to train said horse for the purpose set forth herein; and whereas, the parties agree on the terms and conditions of such training, it is hereby agreed on the terms and conditions of such training as follows:

- Vet Care & Health Requirements:** Owner provides authorization for Trainer to obtain any/all emergency veterinary care to maintain said horse in good health. All other non-emergency care will be approved by Owner. Please complete the information requested on page 3.
- Horse Value:**
 - This horse is insured for \$ _____. Owner will provide a copy of insurance papers and will ensure annual updates are provided along with the information needed on page 3 of this agreement.

- Tack, Equipment & Supplies:** Owner will provide all the appropriate supplies, tack, horse care products, supplements and other equipment in accordance with facility rules, policies and guidelines.
- Release Agreement & Safety Helmet:** Mounted clients must wear properly fastened ASTM F-1163-04a/SEI Certified helmets and have a current signed release agreement on file to participate.
- Payments:** Owner agrees to pay Trainer for all fees for training and services as outlined in the fee schedule. All training fees due are payable on or before the first of each month. Any payment for training and care services not received by the trainer by 6 p.m. on the 4th day of the month shall incur a \$35 late charge. Any account more than 30 days past due will be assessed a \$35 late charge for each month overdue and a 15% interest penalty. Returned checks will incur a \$35 service fee. Checks should be made to "Peak Performance Dressage". Arrangements for direct deposit are appreciated. Mailing address for checks is: 11353 Fulbourn Court, Rancho Cucamonga, CA 91730-8312.
- Expenses:** Owners shall bear all costs for board, training, maintenance and care of said horse. Owner shall pay expenses to the vet, shoer, facility, grooms, feed stores, etc. at the time the service is rendered. Payments for other services, i.e. showing fees, entry fees, clipping fees, the purchase of tack, equipment, supplies, medications and/or other items need for the welfare of the horse that the Trainer deems to be proper and necessary to the care/health/performance of the Owner's horse will be mutually agreed by both parties unless an emergency situation arises. Trainer is authorized to obtain items of care up to a value of \$ _____ without prior permission. All fees for such expenses are due at the time the service is rendered.

7. **Duties of Trainer:** Trainer agrees to perform training responsibilities in a manner consistent with industry practices. The training agreement includes a combination of horse schooling sessions and/or riding lessons to the Owner in accordance with the training plan outlined in the fee schedule and is mutually agreeable to both parties.
8. **Boarding Arrangements:** Owner will complete the Flintridge Riding Club boarding contract and ensure that information pertaining to the supplemental feeding schedule, types of feeds, supplements and other horse care instructions are communicated to the Trainer *and* Barn Manager.
9. **Termination of Agreement:** The term of this agreement shall be on a month-to-month basis. Termination of this agreement shall occur upon mutual agreement of both parties or upon fourteen (14) days written notice to the other party or Owner will be responsible for the full month's training fees and all related expenses. Training fees are not refundable. A final accounting based on a pro-rated schedule shall apply to incidental expenses and optional services. Daily horse schooling fees will be applied to final bills. Discounts associated with full-training packages are not pro-rated since they represent a significant savings over normal lesson and horse schooling fees. All bills for training and expenses are due in advance and must be paid by Owner prior to owner taking possession and/or removing said horse from the boarding facility.
10. **Indemnity:** Owner agrees to indemnify, release and discharge, and hold harmless Trainer, his/her agents, employees, assistants, and all other persons in any way connected with Peak Performance Dressage for all liability or claims, demands, damages, and costs for or arising out of the training, and showing of Owner's horse, whether it be caused by the negligence of the Trainer, his/her agents, employees, assistants and all others against all claims, demands, and causes of action including costs and attorney fees directly or indirectly arising for any action or other proceeding brought by or prosecuted for Owner's benefit contrary to this release extending to all claims of every kind and nature whatsoever whether known or unknown and expressly waive any benefits Owner may have under Section 1542 of the California Civil Code relating to the release of unknown claims.
11. **Amendments & Attorney Fees/Law:** This agreement may be amended at any time by writing into the provisions herein set forth, and the amendment shall be initialed and/or signed by both parties. This agreement shall be interpreted and construed in accordance with the laws of the State of California. Should either party breach this agreement, the breaching party agrees to pay the other's reasonable attorney fees and court costs related to such breach. This agreement shall be binding upon the assigns, heirs and executors of the respective parties.

- Vaccinations current (in the past 6-12 months) for Tetanus, Flu, Rhino, EHV (all strains), EEE/WEE and any others recommended. Flu/Rhino are strongly recommended every 6 months to boost the immune system especially for horses that are traveling to shows for additional protection. Proof of vaccinations within the past 6 months are required by USEF in order to compete in a dressage show.

Training, Lesson & Service Guidelines

The regular schedule for riding lessons & horse schooling are Tuesday, Thursday, Friday, Saturday & Sunday typically early mornings to early afternoon. Weekday afternoon and/or evening lesson times are available by appointment.

These guidelines are meant to promote communication. Changes will be accommodated when possible.

- Please be on time for your scheduled lesson as late arrival will reduce the training session to remain on time for others clients and appointments.
- Be sure the desired time is on the chalkboard for the grooms, 30 minutes is recommended to allow a time to check equipment, bridle, get on, ride through the field and allow at least 15 minutes for warm-up time.
- Check your saddle, pad and boots for proper adjustment.
- Be sure the Comtek box has a working battery. (Be sure to properly insert male/female contacts of battery.)
- Schedule lesson ride times at least a week in advance.
- Horses will be ridden/longed if the client has not sign-up for a lesson ride time.
- If your horse will be frisky, request a turn-out or Equisizer in advance.
- Coordinate time changes with the trainer & stable office in order for your horse to be ready.
- 24 hours advance notice is required for cancellation or changes to the schedule. Horses will be longed, turned-out or put on the Equisizer in the event of late notice.
- Upon arrival at the stables, check to be sure the schedule is on time or if there are any other changes because of unforeseen situations. Also to confirm which arena is being used for that day.
- Check the monthly schedule board on a regular basis for upcoming shows, clinics, judging dates or other activities that could change the routine schedule.
- Away dates for Trainer's judging jobs, judging clinics, horse shows, etc. are listed on the calendar board and are usually posted at least 60-90 days in advance. Make-up lessons or rides are available.
- Advance notice for vacations or other scheduling changes are appreciated.
- When participating in a semi-private or group lesson, clients are encouraged to ride to the level of fitness of horse and rider. Feel free to continue to participate as long as you are comfortable and feel it is of benefit to you and your horse as it is routine for shared lessons to last at least one hour.
- Packaged supplement baggies made in advance by the owner (medications included) will be fed to horses in training by groom (extra cost) or by trainer if the Owner is not coming to FRC on scheduled work days.
- Trainer will consult on horse care appointments with the vet, shoer, chiropractor and/or saddle fitter if the appointment is scheduled within regular work days and hours.
- If the client needs a lesson or another service at a day/time not within the routine schedule, please allow at least 7 days advance notice. Additional charges may apply.
- A general reminder: the grooms will provide two basic services each day such as grooming before & after your ride and either a turn-out or the Equisizer.
- Requests to the grooms for any more services are EXTRA and will be performed IF & WHEN they have time during off peak times. Owner will pay grooms directly for any extra services.

Fee Schedule

The regular schedule for riding lessons & horse schooling are Tuesday, Thursday, Friday, Saturday & Sunday typically early morning to early afternoon. Weekday afternoon and/or evening lesson times are available by appointment. Please allow at least 7 days advance notice.

Full Dressage Training

\$895.00

This program includes at least 16 rides/lessons monthly, comprised of any combination of riding lessons or training sessions. The exact number of lessons or training sessions each month depends on weather, footing conditions, show schedules and other factors. Make up sessions will be scheduled as Trainer/FRC facilities allow. The service begins on the 1st of each month to the end of the month. Payment for training is due by the 4th of each month.

The following services are included:

- On scheduled work days when the client is not coming to FRC, the Trainer will ensure that your pre-packaged supplemental “baggies” will be fed once daily.
- The Trainer will consult on horse care appointments with the vet, farrier, saddle fitter, chiropractor or other industry specialist if the appointment is within the regular work days hours.
- fly spray, show sheen & carrots.

Appointments for additional services outside the regular work schedule can be scheduled but additional charges may apply.

Deluxe Training Package

This package is available for more comprehensive services and will be customized for each client. It can include loaned equipment, laundry of pads/boots/wraps, extra medication, making supplement baggies, etc. Price will depend on desired services.

Dressage Lessons

For riders not in a training program. Lessons are 60 minutes with a maximum of 2 riders in each session. Monthly packages may be arranged, price TBD upon # of lessons. Use of lesson horses (when available) will add \$50 to the lesson price.
